NARRATIVE

On Saturday, February 18, 2012, I responded to 1512 Saragossa Avenue in reference to two dogs that were pepper sprayed. Upon arrival, Ms. Lopez (Victim) advised that her two dogs were playing in the back of her yard. She then advised that she heard both dogs barking so she went outside to find out the reason for the barking. When she located the dogs, in the southwest corner of the residence, she noticed that Mr. Connor (Offender) was spraying the dogs with an unknown substance, later identified as Oleoresin of Capsicum. When she attempted to pick the dogs up to carry them out of the area, she also got contaminated in her face. Ms. Lopez then took both her dogs, a Maltese and a Dachshund to South Dade Animal Hospital for an evaluation. The evaluation was performed by Dr. Sloane Robbins. While in the rear of 1512 Saragossa Av investigating the scene, contact was made with Ms. Connor who was in the rear of 1517 San Rafael Av. Officer Luna advised her that we would come to the front of her residence to speak to her.

Officer Luna, Officer Sotolongo, and myself responded to 1517 San Rafael Av and began speaking with Ms. Connor. Ms. Connor stated that the dogs that live at 1512 Saragossa Av are constantly barking and her husband pepper sprayed the dogs. Mr. Connor then responded to the front of the residence and advised that there was no need for so many "fucking" officers at his residence. I advised him that the reason we were there was that we were investigating two dogs being pepper sprayed. He then stated that he did spray the dogs because "you fucking police don't ever do anything about the issue". Officer Luna then asked Mr. Connor to see the pepper spray at which time he said that he "wasn't fucking getting the pepper spray for you guys". Earlier while in the rear of the yard, Ms. Connor stated that she would let us see the spray. Officer Luna advised Mr. Connor that his wife stated she would let us see the spray. Mr. Connor went inside to get the spray, came back outside, and threw it to Officer Luna.

Acting Sergeant Quintana then arrived on scene and advised Mr. Connor the reason the police were at his residence. Mr. Connor became very agitated and advised us that "we don't ever fucking do anything about the dogs barking" so he sprayed them. During the conversations with Mr. and Ms. Connor, they both stated that Mr. Connor did indeed spray pepper spray on the dogs due to the ongoing barking issue. There is a metal fence that separated both properties. Mr. Connor was not in any danger of being physically harmed by the dogs. Mr. Connor was arrested and transported to CGPD for processing. He was then transported to DCJ.

Note: The pepper spray and doctor reports for both dogs were impounded at CGPD. Pictures were taken of Ms. Lopez's face and arms from the contamination of the spray.

The defendant and his wife both spontaneously stated that the defendant did indeed spray pepper spray on the dogs due to the ongoing barking issue. This act was done to torment the animals in a cruel or inhumane manner. The defendant also stated that he didn't telephone the police for this matter due to us "never doing any fucking thing about it". The defendant was arrested and transported to CGPD for processing and then to DCJ.
